`Summary

Parking and access issues associated with the cul de sac end of Baxter Road, Mascot, in front of Nos. 31 and 33 Baxter Road, Mascot, was previously considered by Bayside Traffic Committee at its meeting on 4 October 2017, item BTC17.125.

Options to modify the existing traffic island forming the road closure has been investigated, and is the subject of this report. This report recommends the modification of the existing cul de sac median island making it smaller to improve access to the adjoining properties, whilst maintaining the existing parking arrangements.

Officer Recommendation

- That approval be given to the modification of the existing median island at the cul de sac end of Baxter Road to provide better access for residents of Nos 31 and 33 Baxter Road, Mascot.
- That approval be given to the installation of 'No Parking' restriction, preventing vehicles from parking at the newly modified cul de sac end of Baxter Road, Mascot.

Background

This matter was previously considered by Bayside Traffic Committee on 4 October 2017, item BTC17.125. The Committee recommendation was presented to Council for consideration on 11 October 2017. Council resolved

"That this item be deferred for an on-site meeting with Ward Councillors and any interested Councillors"

Subsequently, an on-site meeting was conducted on Wednesday 18 October 2017 at 4:30pm. Fifteen (15) residents and local business people were in attendance, in addition to Councillor Rapisardi, Council's Manager City Infrastructure and Coordinator Traffic and Road Safety.

Residents shared their views on the issues, primarily relating to concerns associated with the loss of any existing parking, and the ability to safely access their property. In addition, concern was raised about nuisance property damage at No. 35 Baxter Road adjacent to the western side of the road closure.

Council Officers suggested that the existing landscaped median island at the cul de sac end be reviewed to improve access for residents at Nos. 31 and 33 Baxter Road. It was foreshadowed that removal of a large portion of the landscaped island would likely be required. Most attendees at the meeting seemed to be in agreement with this likely outcome.

The design of the existing median island has been reviewed. It is proposed to remove the landscaped island, and construct a narrow median with bollards to effect and maintain the mid-block road closure. Road pavement will be reinstated in the area of the removed island. A proposed 'No Parking' restriction is recommended at the modified area to maintain accessibility for the driveway to nos. 31 & 33 Baxter Road.

In addition, a bollard will be placed in front of no. 35 Baxter Road to improve the visibility of the footpath area to reduce the occurrence of nuisance damage by turning vehicles.

No parking will be lost as a result of the proposal. All existing parking and bicycle lanes will be retained.

The estimated cost of this project is approximately \$6,500.

The layout of the existing and proposed concrete median island, is shown in the attached drawing.







Subject Chamberlain Road west of Bexley Road, Bexley - proposed parking

Summary

Council has received a request from residents for the installation of parking restrictions in the lower part of Chamberlain Road west of Bexley Road, Bexley.

Officer Recommendation

That approval be given to the installation of some parking restrictions along both sides of the lower part of Chamberlain Road, west of Bexley Road, Bexley, as follows:

- 1 Along the northern kerb line, 10m 'No Stopping' and then 20m 'No Parking' restrictions
- 2 Along the southern kerb line, 10m 'No Stopping' and then 25m 'No Parking' restrictions

Background

Some residents in Bardwell Valley reported that the lower part of Chamberlain Road is too narrow for the two way street whilst parking is allowed on both sides of the road.

Chamberlain Road is a residential street which is being split into two levels. Each level of Chamberlain Road provides service for the two way flow.

The lower part of Chamberlain Road provides access in and out to Bexley Road. Only 'left in' and 'left out' movements are allowed at the intersection of Chamberlain Road and Bexley Road. It has no paved footpath on both sides of the street. It has a steep slope toward Bexley Road.

The top level has a cul de sac end on the eastern side. It has a paved footpath and a stairway on one side.

The road carriageway width of the lower part of Chamberlain Road is approximately 5.1m wide.

No accidents had been reported in Chamberlain Road for the period of five years between 2012 and 2016.

A parking survey in Chamberlain Road was conducted with affected residents in June/July 2017. The questionnaire survey suggested some 'No Parking' and 'No Stopping' restrictions be applied to Chamberlain Road.

By the end of survey period, the following seven (7) responses were received;

- 3 are against the proposal
- 4 support the proposal

The objectors raised concerns about the loss of parking spaces that have been used in Chamberlain Road for a very long time.

The supporters raised concerns about the difficulties of gaining access and egress to their residences.

There is no overwhelming support on either side of the argument.



Summary

This report provides detailed design drawings for traffic calming scheme in Fontainebleau Street between Rocky Point Road and Napoleon Street, Sans Souci, including raised pedestrian refuge islands with associated 'No Stopping' restrictions at the intersection of Tuffy Avenue and Fontainebleau Street.

Officer Recommendation

- That endorsement be given to the construction of raised pedestrian refuge islands and associated 'No Stopping' signs in Tuffy Avenue at its intersection with Fontainebleau Street, Sans Souci as shown in the detailed drawing.
- That approval be given to the installation of separate kerb parking lanes and through lanes lines with raised reflective pavement markers on edge lines and centres lines in Fontainebleau Street between Rocky Point Road and Napoleon Street as shown in the detailed drawing.
- That approval be given to the change of priority control at the intersection of Lawson Street and Fontainebleau Street from Give Way to Stop priority control.

Background

Council at its meeting of 7 September 2016 via the recommendations of the Rockdale Traffic Committee meeting of 10 August 2016 (via item RT08) resolved at follows:

- "1 That in principle support be given to the installation of separate kerb parking lanes and lanes lines with raised reflective pavement markers on edge lines and centres lines in Fontainebleau Street between Rocky Point Road and Napoleon Street, subject to the availability of funding.
- 2 That in principle support be given to the installation of a raised island with additional stop/give way signs along with additional street lighting in Tuffy Avenue at its intersection with Fontainebleau Street, subject to the availability of funding.
- 3 That in principle support be given to change of priority control at the intersection of Lawson Street and Fontainebleau Street from Give Way to Stop priority control, subject to the availability of funding.



Summary

Council has received a request from the builders at Nos.51 Gordon Street, Botany for the provision of a 'Works Zone' in Gordon Street to facilitate the construction of a residential flat building for the duration of 26 weeks.

Officer Recommendation

That approval be given to the installation of 8m of 'Works Zone, 7am- 5pm, Mon – Fri and 8am- 1pm, Sat' restriction in Gordon Street for Nos.51 Gordon Street, Rosebery, for a duration of 26 weeks, subject to relevant conditions.

Background

It is often recommended that kerb side parking surrounding a large construction site be kept clear of parked vehicles to allow access for heavy plant and vehicles and the removal/delivery of associated materials.

To facilitate construction activity, it is recommended that a works zone be provided in Bonar Street, Arncliffe.

In accordance with Road Rules 2014, Rule 181 states that:



Works zone

This sign means that a driver must not stop in a works zone unless the driver's vehicle is actually engaged in construction work in or near the zone. Any vehicle may stop to pick up or set down passengers.

Hours of operation; '7am- 5pm, Mon – Fri and 8am- 1pm, Sat' will apply to this works zone.







Subject Jackson Drive, Mascot, east of Kent Road - Proposed 'No Stopping'

and '1P 6am-6pm Mon-Fri' restrictions

Summary

Jackson Drive is a newly established lane as part of the redevelopment of sites along Kent Road and Coward Street, Mascot. Parking restrictions are proposed along the laneway to assist with safe traffic manoeuvring and parking within the area.

The lane is 6m wide with indented parking along northern end of the cul-de-sac end in the lane way.

Officer Recommendation

That approval be given for the installation of parking restrictions in Jackson Drive east of Kent Road, Mascot, as follows:

- 1 That 111m of 'No Stopping' restrictions be installed along the northern side of Jackson Drive
- 2 That 98m of 'No Stopping' restrictions be installed along the northern side of Jackson Drive
- That two existing 6m of '1P, 6am-6pm Mon-Fri' restrictions be converted to 'No Stopping' restriction in the northern cul-de-sac end to facilitate u-turning movements.
- That 16m of '1P, 6am-6pm Mon-Fri' restrictions be installed along eastern side and western side of Jackson Drive each respectively.

Background

A number of new developments have been completed and/or are in the construction phase along Coward Street and Kent Road. As part of the development, Jackson Drive has been established as a new access lane way. Some parking signage has been installed in conjunction with developments.



Summary

The conditions of consent for No. 289 King Street require the installation of 'No Parking' restriction along the northern kerb line of King Street, west of O'Riordan Street, Mascot, to facilitate safe access. This report recommends the implementation of these restrictions.

Summary

A request has been received to improve traffic and pedestrian safety at the intersection of Princes Street and Parliament Terrace, Bexley

Officer Recommendation

That approval be given to the provision of double barrier lines with rumble bar treatment at the intersection of Parliament Terrace and Princes Street, Bexley.

Background

Parliament Terrace is a collector road and Princes Street is a local street, both with a sign posted limit of 50km/h. The streets form a cross intersection with 'Stop' priority control in Princes Street.

Residents in the vicinity are concerned about vehicles cutting corners at speed potentially creating danger for pedestrians and children visiting the park on north-eastern corner of the intersection.

The crash data from Roads and Maritime Services for the latest five year period ending September 2016 indicate 2 reported non-injury crashes at this intersection.

All crashes are adjacent vehicle type crashes indicating that vehicles in Princes Street are failing to recognise the priority for traffic movements.

Traffic volume in Princes Street is relatively low with 744 vehicles per day. Parliament Terrace carries approximately 3,400 vehicles per day.

To highlight Princes Street as the minor street at the intersection, it is recommended that double barrier lines be painted with rumble bar treatments.



Summary

The Ramsgate Beach town centre has recently been upgraded with widened footpaths, street lighting and landscaping. In conjunction with these works, modifications have been undertaken to traffic and parking arrangements in the centre.

This report recommends installation of a pedestrian crossing on Ramsgate Road, east of the Alfred Street intersection, and alteration to parking and traffic signs throughout the centre.

Officer Recommendation

- That consideration be given in principle to provide a staggered marked footcrossing in Ramsgate Road, Ramsgate Beach, east of Alfred Street.
- That consideration be given in principle to install raised marked footcrossings at the existing marked footcrossing in Ramsgate Road, west of Alfred Street and at the newly proposed marked footcrossing east of Alfred Street, subject to availability of funding.
- That detailed plans of the proposed raised pedestrian crossings in Ramsgate Road, Ramsgate Beach, be submitted to Bayside Traffic Committee for further consideration.

Background

Pedestrian Crossing – Ramsgate Road, east of Alfred Street

As part of the planning for the Ramsgate Beach Town Centre upgrade, it was envisiaged that an additional pedestrian crossing on Ramsgate Road, just east of Alfred Street would be required. At the time of completing the design however, there were insufficient counts to warrant a pedestrian crossing.

Additional pedestrian traffic has now been generated since the upgrade works have been undertaken, and the construction of new residential apartment buildings on the northern side of Ramsgate Road.

In accordance with Roads and Maritime Services' Supplement to Guide to Traffic Management (Austroads) – Part 6 – for special warrant:

In certain circumsances where the product of PV (Pedestrians x Vehicles) is greater or equal to 45,000 (but less than 60,000) and P (pedestrains) is greater than or equal to 30 and V (vehicles) is greater than or equal to 500 then consideration given to a potential pedestrian crossing site.

As the location of the proposed marked footcrossing is situated near the roundabout at the intersection of Ramsgate Road and Alfred Street, it is recommended that the crossing line be staggered in two parts, to be separated by a pedestrian fencing at the existing median strip. The northern staggered part of the crossing to be placed at least 10m from the circulation path of the roundabout to accommodate a car. A kerb blister island and a pedestrian pram ramp on the northern kerb line of Ramsgate Road east of Alfred Street have to be constructed for the newly proposed marked footcrossing.

It is recommended that the marked footcrossing be implemented as the site has met the RMS special warrants for the marked footcrossings.

Existing bus zones in Ramsgate Road will not be affected by the proposal.

Raised Thresholds - Ramsgate Road

To enhance pedestrian safety in Ramsgate Road, it is recommended to install raised pedestrian crossings at the existing marked footcrossing and the newly proposed marked footcrossing in the west and east of Alfred Street respectively.

Existing signage in Ramsgate Beach Car Park

There will be some alterations to existing signage in Ramsgate Beach Car Park to enhance safety.

Some redundant traffic signs will be removed, others will be altered or lowered and additional signs will be installed as part of the sign maintenance work including:

- The installation of bollards or other appropriate device to deter vehicle entry to the Chuter Avenue and The Grand Parade plaza areas:
- The raised/traffic calming pedestrian crossing(s) at Ramsgate Road;
- The installation of a 'No left turn' sign facing traffic upon entry to the roundabout at the intersection of Alfred Street and Ramsgate Road;
- Investigate provision of traffic islands adjacent the Coles carpark entry;
- Replace 'No Entry, Vehicles Under 6m Only' with 'No Entry, Vehicles Under 6m Excepted':
- Remove three special hazard signs in Alfred Street south of Ramsgate Road;
- Remove 'Rear to Kerb' or 'Front to Kerb' signs along the edge of Ramsgate Road;
- Lower some of 'No Entry' signs;

Council has received an application for a disability parking zone at 90 Wilson Street, Botany. There is generally unrestricted parking along Wilson Street. Parking in Wilson Street is in high demand due to the presence of a newly constructed residential block.

In accordance with Australian Standard *AS2890.5 Parking*. Any parallel parking spaces marked as disabled parking bay should be 3.2m wide and 7.8m long and it should also have kerb ramps provided.

The current kerb and footpath infrastructure in front of 90 Wilson Street does not allow for the required space for a disabled parking bay according to the current Australian Standards.

As an alternative to the requested disabled parking bay, it is proposed that 1 hour parking limit be provided at the subject location. The proposed 1P parking would allow the applicant's mother, who is a current NSW Mobility Parking Scheme Holder, to have unrestricted parking within the 1P timed parking zone. This alternative option will increase parking turn-over and increase the availability of this space.

This proposal allows all current NSW Mobility Parking Scheme Holders to have unrestricted parking but all other road users would need to comply with the 1P timed parking restriction.

The locality of the proposed and existing parking, is shown in the attached drawing.



All other Items without notice will be referred to Council officers in the first instance.

Matters that have been investigated and warrant the exercise of the Delegation to Council for the Regulation of Traffic, will be referred to the Bayside Traffic Committee at the next available opportunity.

Other matters that have been investigated and do not require exercise of the Delegation to Council are dealt with as administrative matters and the appropriate response and action will be provided (eg. providing advice to customers, referral of matters to the relevant authority, replacement of missing signs, repainting line marking, etc). These matters will not be referred to the Bayside Traffic Committee.

Informal Items - Traffic Engineering Advice

In accordance with the Roads and Maritime Service Guidelines, the Bayside Traffic Committee (BTC) members may wish to consider traffic issues or seek advice, on matters that are outside the Delegation to Council for the Regulation of Traffic from the Roads and Maritime Service (e.g. installation of speed limits or traffic control signals). As these issues do not require the exercise of delegated functions at that point in time (though they may or may not require it in the future) they will should not be dealt with as formal items by the BTC. The BTC members may take advantage of the knowledge and experience of the other members to help them to resolve or clarify an issue. When wishing to utilise the expertise of the BTC members in this manner, Council will include items on the agenda under a separate Informal Items section. Informal items should be dealt with following the completion of formal BTC items where Council intends to exercise a delegated function. Any outcomes from discussions on informal items cannot be included in the BTC report to the Council. However, Council can use any outcomes from these discussions in their deliberations on such issues.
