#### Summary

Council has received a request for improving safety for traffic at the bend of Hannam Street and Turrella Street, Turrella, created as a result of long-term parking.

# **Officer Recommendation**

That approval be given for installation of 20m 'No Parking' restrictions along eastern side of Hannam Street outside house number 136 Turrella Street and 4 Hannam Street, Turrella.

# Background

Hannam Street and Turrella Street meet at a bend instead of forming an intersection. The streets form part of State Transit Authority's bus route 473 between Rockdale and Campsie.

A number of streets in Turrella are narrow, carrying two way traffic with demand for residential parking on-street. Due to recent property redevelopment along Henry Street, Reede Street and Turrella Street, the demand for parking in the area has increased along with long-term commuter parking.

Concerns have been raised about parking at the bend of Hannam Street and Turrella Street, where buses are forced to straddle over the double-barrier lines. The lane width is about 4m and with vehicles parked along the kerb-line for unrestricted time, it creates potentially unsafe conditions for vehicles including buses.

Site observations have determined vehicles crossing double barrier lines to traverse this bend when vehicles are parked outside house number 2. Hannam Street carries between 2200 and 3000 vehicles per day approximately. The 85<sup>th</sup> percentile speed is approximately 55km/h despite the geometry and narrow width.

In accordance with the RMS's crash data for the five year period ending December 2016, 1 non-injury crash has been reported in the vicinity of the bend with Road User Movement (RUM) code 49. It was related to vehicle manoeuvrability but does not assist with the identification of specific cause.

It is recommended that the 20m 'No Parking' restrictions be signposted as shown in the attachments to keep this area free of parked vehicles, allow residents to undertake loading/unloading type activities and help improve safety for bus movements and general traffic. The proposed restriction will remove 1 parking space. However, in accordance with

NSW Road Rules, a minimum 3m travelling lane must be available without obstruction. This does not allow parking at the subject location regardless of the proposal.

#### Summary

Council has received a request from the Management of Pagewood Public School to provide some drop off and pick up areas in Holloway Street, between Page Street and Dalley Avenue.

#### Officer Recommendation

That approval be given to the installation of twelve (12) parking spaces in Holloway Street, between Page Street and Dalley Avenue in front of Page Street and Dalley Avenue, for set down and pick up areas, with a 'P15 Minute, 8am-9.30am and 2.30pm-4pm, School Days, restriction along the northern kerb line of Holloway Street, as follows:

- 1 From 23m to a point at 59m east of Page Street proposed six (6) parking spaces
- 2 From 20m to a point at 56m west of Dalley Avenue proposed six (6) parking spaces
- 3 Existing 'No Stopping' restrictions at both ends of Holloway Street near Page Street and Dalley Avenue be retained.

#### Background

Parking issue in Dalley Avenue in front of Pagewood Public School was previously considered by Bayside Traffic Committee on 7 March 2018, Item BTC18.23. The Committee recommended that this matter be deferred for further consultation with the Principal and Port Botany Ward Councillors.

On 7<sup>th</sup> March 2018, Council had received a letter from the President of P&C of Pagewood Public School requesting the provision of a 'Kiss and Ride' area to be provided in Holloway Street.

A discussion with the school principal has confirmed that the school needs some Kiss and Ride areas in Holloway Street. He recommended twelve (12) parking spaces to be signposted with P15 minutes. The twelve parking spaces are to be divided into two sets of six (6) parking spaces; one set near Dalley Avenue and the other set Page Street. The school has two pedestrian driveways in Page Street and Dalley Avenue.

The existing parking arrangement in Dalley Avenue will be retained.

The proposed P15 minute restrictions in Holloway Street will not affect adjoining residents or businesses in Holloway Street as this area is situated in front of the school.

The locality of the existing and proposed parking restrictions in Holloway Street, is shown in the attached documents.

#### Summary

It has been observed during routine inspections, that some vehicles are seen to travel in the wrong direction of the one way street northbound in Marsh Street access road at the rear of Mercure Hotel. This will cause some traffic hazards for head-on collisions.

# **Officer Recommendation**

That approval be given to the painting of two (2) of one-way road pavement arrows to reinforce the existing sign-posted one way street in Marsh Street Access Road, Wolli Creek, between Marsh Street and Rockwell Avenue.

#### Background

Marsh Street access road is situated at the rear of the Mercure Hotel, Wolli Creek, and is being sign-posted as a one way street, northbound, between Marsh Street and Rockwell Avenue.

Two new driveways have been recently constructed near Mercure Hotel linking Levey Street to the west to Marsh Street access road to the east. All exiting traffic from these two new driveways are supposed to turn left out into Marsh Street Access Road, travelling northbound in accordance with the existing one way street. However, some vehicles are seen to travel in the wrong direction.

It is recommended to paint two (2) of one-way road pavement arrows reinforce the existing sign-posted one way street in Marsh St access road, Wolli Creek as shown in the attached drawing TC1428.

# Summary

This report presents a proposed new car park in Pine Park, Sans Souci, between Ramsgate Road and Sandringham Street and the removal of temporary car park in Carruthers Drive. The new car park will be sign-posted with '10 pm – 5 am' parking restriction. The proposed new car park along The Grand Parade and the removal of a temporary car park in Carruthers Drive near the waterfront.

The temporary car park in Carruthers Drive was previously considered by Rockdale Traffic Committee on two occasions in 2016.

#### **Officer Recommendation**

- 1 That the Committee endorse the proposed Pine Park Car Park along The Grand Parade between Ramsgate Road and Sandringham Street, Dolls Point.
- 2 That approval be given to the removal of a temporary car park in Carruthers Drive near the waterfront north of Sandringham Street.
- 3 That approval be given to the installation of 'No Stopping, 10pm-5am' restrictions in the new car parks of Pine Park between Ramsgate Road and Sandringham Street.

#### Background

The Major Projects component of the Stronger Communities Fund has allocated funding to projects that will deliver large scaled new or improved infrastructure or services to the community. The Stronger Communities Fund Assessment Panel recommended three projects, one of which was Pine Park Masterplan - Ramsgate Beach. Approval by resolution for this project was made at the Bayside Council meeting held on 12 April 2017.

A Lead Consultant and consultancy team was appointed by Council at the Council meeting held on 11 October 2017 to refine the Masterplan, develop the design and prepare construction tender documentation to ensure the project is delivered by 30 June 2019, in line with Stronger Communities Fund requirements.

The Masterplan was reviewed following the allocation of funding to the project and a draftscoping plan to deliver the project developed and was approved by Council in December 2017. The refined Masterplan and project implementation scope incorporates the following:

- Removal of car parking in Caruthers Drive, prime foreshore location, returning it to pedestrians and cyclists;
- Construction of a new, larger car park off the Grand Parade between Ramsgate Road and Alice Street with a one way in/out internal driveway system;
- Provision of suitable access and short term stopping for deliveries, loading, drop off/pick up, community buses and Council maintenance and emergency access opposite Ramsgate Road and Alice Street;
- Improved park circulation routes and reduction of user conflict and access issues between pedestrians (all abilities), parkland and park amenities users, cyclists and vehicles;
- A functional and attractive main entry node and forecourt opposite Ramsgate Road and secondary node opposite Alice Street; and
- Improved infrastructure, safety, open space quality, user amenity and public satisfaction.

Key management principles of the Cook Park Plan of Management and the Conservation Management Plan have been considered and incorporated.

Pine Park is part of Cook Park – an 8.5km linear parkland between the Georges River in the south and the Cooks River in the north and on the western shores of Botany Bay. The Park is regionally significant as both a recreation destination and as a link to adjoining suburbs through its pathways, cycleways and coastline and has important historical meaning in the development of the local area.

The following park design and management issues came to the fore through investigations, site visits and the community engagement process

- Carruthers Drive should be retained for pedestrians and cyclists and public parking and vehicle access removed. Some of this parking should ideally be accommodated in new carparks although Carruthers Drive is not well utilised for most months of the year;
- The exposed, hot, glary environment of the southern promenade/Carruthers Drive
- Surfaces and infrastructure pose safety hazards and are unfriendly for those less abled, prams, mobility scooters and the like;
- Speeding cyclists pose a hazard to pedestrians and slower leisure cyclists and families;
- Hazards around the small carpark adjacent the Ramsgate Life Saving Club (RLSC). This area is congested at many times of the week with many competing and conflicting uses operating within a small space. Sightlines for pedestrians and cyclists are poor. Pedestrians need to be on alert for cyclists, cars, small buses and trucks whilst trying to access the 2 pedestrian crossings at the intersection, use the share paths and access the beachfront;
- Car park entrances and exits need to be carefully sighted especially at the intersection with Ramsgate Road but also at Alice Street;
- The secondary entry opposite Alice Street needs improved resolution and demarcation of pavements and pathways, removal of hazards and better entry off The Grand Parade. A community bus bay or parking is needed adjacent the amenities;

This proposed car park in Pine Park matter was previously discussed, informally at the General Session of the previous Bayside Traffic Committee Meeting on 7 March 2018. There are a couple of items that should be clarified

1 "Slip lanes off The Grand Parade to access the car parks are not required under the design standards" – Austroads GRD Part 3 (Sedtion9.3.2) and GRD Part 4 provide details on the requirements for deceleration lanes for intersections and interchange. 2 "There are established design guidelines and practice and project examples of kerbside cycle paths" – RMS – NSW Bicycle Design Guidelines. Section 4.2 – Bicycle Paths own a road reserve, Austroads – GRD, Part 6A, Section 5, Location of Paths. There are many examples of separated off road cycle paths including Oxford Street Centennial Park.

#### Summary

This report provides detailed design drawings for the pedestrian refuge island in Riverside Drive, the funding for which is available in current year's traffic facilities budget.

#### Officer Recommendation

That endorsement be given to the detailed design drawings for pedestrian refuge island in Riverside Drive, Sans Souci, east of Napoleon Street for implementation in current financial year.

# Background

Council at its meeting on 9 November 2016 via the recommendations of Rockdale Traffic Committee meeting had resolved as follows:

- 1. "That approval be given in principle for the installation of a pedestrian refuge island in Riverside Drive, Sans Souci east of Napoleon Street in front of the amenity block, subject to availability of funding.
- 2. That the detailed design plan of the above pedestrian refuge be submitted to Traffic Committee for further consideration"

The amenity block in Scott Park is listed on the special rate variation program for renewal. The pedestrian refuge island will serve as a safe crossing point for pedestrians by providing a two-stage crossing. The proposed location for pedestrian crossing has currently been signposted with 'No Stopping' restrictions on both sides of Riverside Drive to enhance visibility for those crossing at this location.

Council was unsuccessful in receiving a grant from RMS under 2017/2018 Road Safety and Active Transport Program. However, the construction of this pedestrian refuge island will be funded by Council's budget.

A detailed plan of the pedestrian refuge island is presented to the Traffic Committee for endorsement as funding is now available in current financial year's budget for traffic facilities.

#### Summary

Council has received a request to consider parking conditions for the residents living in individual dwellings in Station Street, Arncliffe along the northern kerbline between Belmore Street and Done Street.

## Officer Recommendation

- 1 That approval be given to change the "2P 8.30am-6pm Mon-Fri 8.30am-12.30pm Sat' restrictions for the 90 degree angle parking along southern kerbline of Station Street to "2P 8.30am-6pm Mon-Fri 8.30am-12.30pm Sat Permit holders excepted Area ARN'
- 2 That the eligible residents in Station Street, Arncliffe along the northern kerbline between Belmore Street and Done Street be advised of Council's decision and invited to apply for permits at a cost as per Council's fees and charges
- 3 That parking spaces in the 90 degree angle parking 10 spaces in Station Street, be delineated.

#### Background

Council has received a request to consider the parking situation for residents living in individual dwellings in Station Street between Belmore Street and Done Street. The properties are old, with no off-street parking and no possibility of modification to satisfy their parking needs off-site.

There is currently unrestricted parking available in Station Street outside these properties. Demands for long-term and short-term parking are high in this precinct due to Arncliffe Station and the retails precinct along Firth Street. Residents have to compete with other users for parking day and night.

These properties are similar to those in Done Street, where off-street parking cannot be provided. Council has installed resident parking scheme to assist the residents in Done Street, with a, "2P 8.30am-6pm Mon-Fri 8.30am-12.30pm Sat Permit holders excepted Area ARN'.

Over the years, the scheme has been assessed to be functioning adequately, balancing the long-term as well as short-term parking needs in the street.

There is an opportunity to include the current 90 degree angle parking spaces (10 spaces) in Station Street within the resident parking scheme Area ARN. This will provide additional opportunity for the properties in Station Street to access the parking scheme.

This proposal has minimal impacts on general parking in the area whilst improving amenities for the residents.

As these issues do not require the exercise of delegated functions at that point in time (though they may or may not require it in the future) they should not be dealt with as formal items by the BTC. The BTC members may take advantage of the knowledge and experience of the other members to help them to resolve or clarify an issue. When wishing to utilise the expertise of the BTC members in this manner, Council will include items on the agenda under a separate Informal Items section.
