Note: A duly signed and delivered notice of surrender of a development consent referred to in the regulation:

- (a) takes effect when the consent authority notifies the person that:
 - (i) it is satisfied that so much of the development as has been carried out in compliance with any condition of the consent, or any agreement with the consent authority relating to the consent, that is relevant to that part of the development, and
 - (ii) that the surrender will not have an adverse impact on any third party or the locality, and
- (b) operates, according to its terms, to surrender the consent to which it relates.
- * **Particulars** of a proposed modification include a description of the modification to be made to the approved activity and the locality of the proposed modified activity.
