Summary

The 'Easy to do Business' service will make it easier and faster to establish a business in the Bayside LGA. The sectors currently supported include cafes, restaurants and small bars.

Service NSW will be in attendance at the Committee meeting to present to Councillors and answer any relevant questions.

Officer Recommendation

- That authority is delegated to the General Manager to enter into a contract with Service NSW for the Easy to do Business initiative.

Background

Council have been approached by Service NSW to participate in the federally funded 'Easy to do Business' service. There is no cost for councils or for business owners to participate. It helps businesses navigate three layers of government by giving them access to business concierges who can give them general guidance, connect them with specialist support services and advisory networks and can help them complete applications so they are assessment ready.

This is a joint initiative of the NSW Small Business Commissioner and Service NSW.

Subject Renew our Libraries

Summary

Libraries are a vital piece of social infrastructure for our community.

NSW public libraries receive over 35 million visits a year, but State recurrent funding has not increased to match the demand. Funding was cut by 5% in the 2018-19 State Budget. Access to infrastructure funding was removed for metropolitan libraries.

Annually the NSW Government contributes \$23.5 million to support over 360 libraries across the State. This compares with a local government contribution of over \$314 million.

At 7.8% of total funding, the NSW contribution to libraries is the lowest in Australia. It is 18% in Victoria and 12% in Queensland.

The Renew Our Libraries objectives are to double the funding for public libraries and create a long term, sustainable funding model to invest in our libraries into the future.

Officer Recommendation

That the Committee recommends to Council the 'Renew our Libraries' campaign be supported and endorsed.

Background

NSW public libraries are struggling to keep up with the increasing demand for their services and library funding is at a crisis point. Recently there has been a cut of 5% to recurrent public library funding.

At the 2017 LGNSW Conference, all councils unanimously agreed to joint advocacy and the NSW Public Libraries Association (NSW PLA) and Local Government NSW (LGNSW) have united to create Renew Our Libraries.

Renew Our Libraries is an advocacy initiative, which brings together councils, public libraries and their supporters into a grassroots effort to demand action and funding commitments from all political parties in the lead up to the 2019 NSW State Election.
