CamerART Terms & Conditions 2019

- Terms & conditions may be amended, deleted or added at the discretion of Bayside Council and will be published on Bayside Council's website.
- 2. By completing the entry form and submitting it with your image(s) you agree to the full terms & conditions as entry to this competition is deemed acceptance of these terms & conditions.
- 3. Each entrant may submit a maximum of three (3) entries.
- 4. Image resolution should be saved as JPEG 300dpi. Minimum 2 megabytes, maximum size 10 megabytes.
- 5. Other acceptable picture formats include: BMP, PNG and TIFF. Bayside Council may choose not to accept pictures submitted in formats other than those specified above.
- **6.** Content of an inappropriate or offensive nature is not permitted.
- 7. Illegible, incomprehensible and incomplete entries will not be accepted and deemed invalid.
- 8. Computer generated images are not permitted.
- **9.** Entrants must ensure date and time stamps have been disabled from their cameras and must be omitted from their photo(s).
- **10.** Images are not to have text and / or symbols (including copyright, photographer's name or company).
- **11.** Collaged or grouped images submitted as a single image will not be accepted.
- **12.** Council will permit entrants who have altered and / or have had an effect laid to the image.
- 13. This competition is being run by Bayside Council.
- **14.** Images must only be taken within the Bayside Council Local Government Area and taken within the last 12 months.
- 15. Images may be in black & white, colour or sepia.
- 16. Entrants must be an Australian Citizen or permanent resident, and be either a resident of Bayside Council Local Government Area, working in the Bayside Council Local Government Area, or go to school in the Bayside Government Area. Employees and Councillors of Bayside Council and their immediate families are not eligible to participate in the competition.

- 17. Entries must meet the specifications and format as set out in this document; and include a completed photo release form where necessary.
- 18. Bayside Council will exhibit selected images during the Bayside Arts Festival at various locations, online at Council's website for the period of the exhibition and later use to be determined by Bayside Council and primary sponsor Sydney Airport.
- **19.** Inclusion of any image is subject to selection by the Judging Panel and primary sponsor Sydney Airport.
- **20.** No correspondence will be entered into regarding these terms & conditions or the decisions of the Judging Panel or Bayside Council.
- 21. Bayside Council reserves all rights, and retains the final decision in respect of any issue relating to '**CamerART'**, including but not limited to the selection process, organisation, running and administration of the competition and exhibition.
- **22.** The entrant must clearly state that they are the creator of the image.
- 23. The entrant must own the copyright of the image.
- **24.** The entrant indemnifies Bayside Council and Sydney Airport against any claim, legal or otherwise, that may arise out of publication of the image.
- **25.** The entrant grants Bayside Council and Sydney Airport Corporation Limited the right to:
 - i. Maintain a digital copy of the image(s); and

ii. Enlarge and adapt the image(s) in order to fit the large scale format for display; and

iii. Exhibit the reproduced work in the Bayside Council Town Centres at dates to be determined by Bayside Council.

- **26.** You warrant that you are the owner of all copyright in the image(s) or have obtained all necessary approvals to permit the use of the image(s) for display
- 27. Council and primary sponsor Sydney Airport may reproduce/publish and display the image(s) (or any part of) in any media format, including but not limited to advertisements, postcards, brochures, posters, television/print media, website and annual reports, only for the purposes of:







i. Publicity and promotion of the City and/or competition:

ii. The catalogue of the competition; and

iii. Creating a non-commercial archive of the competition

- 28. As a condition of entering this competition, each entrant licenses and grants the Promoter and any sponsor of the Bayside Arts Festival 2019, including Sydney Airport Corporation Limited, along with the Promoter's and Sponsors', its affiliates and sub-licensees a non-exclusive, royalty-free, perpetual, worldwide, irrevocable, and sublicensable right to use, reproduce, modify, adapt, publish and display their entry (which shall include Content) for any purpose, including but not limited to future promotional, marketing or publicity purposes, in any media, without compensation, restriction on use, attribution or liability.
- **29.** Council and its sponsors will acknowledge you in all publicity of the competition as the creator of the work.
- **30.** Whilst Council will take care to ensure the integrity and quality of the reproduced image(s), you acknowledge that enlargements may result in slight variations to the image(s).
- **31.** Depending on the subject matter you may be asked to provide a **photo release** as a condition for inclusion of the image(s) for display. Failure to provide this release may result in your image(s) not being included in the display.
- **32.** The Promoter may need to collect personal information about each claimant and may for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, gift suppliers and regulatory authorities. Participation in the Promotion is conditional on providing this information.
- **33.** By entering, the Promoter may, for an indefinite period, unless otherwise advised, use the information for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the entrant and for such other purposes as set out in our Privacy Policy.
- 34. Entrants should direct any request to access, update or correct information to the Promoter. All personal details of entrants will be stored in accordance with the Privacy Policy. Upon the claimant's request, information provided will be removed from the Promoter's active marketing database. - **35.** All entries remain the property of the Promoter.
- **36.** Finalist Photographs will be judged by a Judging Panel appointed by Bayside Council.
- **37.** Judges decisions are final, with the exception of the People's Choice award which will be chosen by the public via a voting system.
- **38.** Council at its discretion will select photographs to be placed on exhibition at the conclusion of the final judging. The exhibition will include all prize winners.
- **39.** The winner of the competition will be selected by a panel of judges appointed by Bayside Council. The decision of the judges is final and no further correspondence will be entered into.
- **40.** Prizes will be awarded in each category (junior, youth and open) plus a popular choice category known as the People's Choice Award which will be selected by the public via voting system.
- **41.** Each person may enter one, or more categories for which they are eligible. However, only one photo/entry per category will be accepted.
- **42.** By entering a photograph into this competition the entrant guarantees to Bayside Council that the above entry requirements have been met.
- **43.** Bayside Council reserves the right to withdraw a prize in the event of an entrant being unable to satisfy the terms and conditions listed here.
- **44.** The judges will select one winner and one runner-up from each category. The judges reserve the right to not award a prize if they do not have a worthy recipient.
- **45.** Winners will be announced by Saturday 27 April, 2019 by Bayside Council and published on Council's website.
- **46.** All images must be submitted via Bayside Council's website no later than midnight on Sunday 31 March 2019.
