Proposed "permit parking scheme" in Wellington Street, Mascot - SURVEY

We have received requests from residents for the installation of a resident parking scheme in Wellington Street, Mascot. Before the scheme can be implemented in the street and the permit issued, the following criteria must be met:

More than 75% of households in the street must be in favour of the scheme and more than 75% of parking spaces on the street(s) are occupied on our 4 (four) normal visits.

Once the street is eligible for the Permit Parking Scheme, each applicant will need to meet the eligibility criteria such as establishing the residential status and the vehicle is registered in NSW. A maximum number of two permits may be issued for any one household depending on the availability of spaces on the street.

The parking permit annual fee for 2018/2019 is \$26 for the 1st car and additional car is \$77. These fees are to help cover the cost of installation of signs, stems and permit stickers. However, Council has waived the fee for the 1st vehicle of the holders of a Pensioner Concession Card issued by Centrelink or a Gold Card by Department of Veteran Affairs.

Please note, a petition will not be accepted as a response to this survey. For the purpose of collating replies, Council will consider responses based on a household and not per capita. Each household has one vote.
