## Background

Council has received a request to install a resident parking scheme '2P, 8.30 am – 6 pm, Permit Holders Excepted Area ARN2' restriction along the eastern kerb line of Barden Street, south of Station Street, in front of properties from No. 2 to No. 20 Barden Street, Arncliffe. These houses are located on the top of a retaining wall and have no off-street parking.

Barden Street south of Station Street, Arncliffe, is situated near a church and located in the proximity to Arncliffe Shopping Centre and Arncliffe Railway Station. The community hall in the vicinity also contributes to demand for parking. As a result, parking in Barden Street is in high demand. Residents of those houses find it hard to park near their residences especially during business hours and church services at the week-ends.

Parking is allowed on both sides of Barden Street with unlimited times.

Four site inspections were conducted and it was found that that section of the street is subject to high parking demands.

It is recommended that a resident parking scheme be installed in front of Nos 2 to Nos.20 Barden Street, Arncliffe. The spokesperson for affected residents has advised that residents are willing to pay for the parking permits in accordance with Council's Fees and Charges.

The locality of the new parking restriction in Barden Street is shown in the attached plan.



## Summary

Council has received a request for the signposting of 'No Stopping' restrictions at the intersection of Beaconsfield Street and Harrow Road, Bexley due to illegally parked vehicles.

## **Officer Recommendation**

- 1 That approval be given to the signposting of statutory 10m 'No Stopping' restrictions along western kerbline of Harrow Road on both sides of Beaconsfield Street, Bexley.
- 2 That approval be given to the signposting of 10m 'No Stopping' restrictions along southern kerbline of Beaconsfield Street west of Harrow Road, Bexley.
- 3 That approval be given to the signposting of 20m 'No Stopping' restrictions along northern kerbline of Beaconsfield Street west of Harrow Road, Bexley due to the presence of a pedestrian refuge island.

## Background

Beaconsfield Street is a 9.5m wide residential street in Bexley. Parking is allowed on both sides of the street. Beaconsfield Street links two regional roads; Harrow Road to the north and Queen Victoria Street to the south.

The intersection of Beaconsfield Street and Harrow Road lies in proximity to Rockdale Town Centre area and Rockdale Railway Station. There are some retirement villages in the vicinity as well as schools. Demand for parking can be high at times. Especially at night time, residents claim that parking demand is significant and people tend to park in close proximity to this intersection. There are load limit restrictions in Beaconsfield Street but residents claim that trucks are also parked in close proximity of this intersection regularly.

Crash data provided by Roads and Maritime Services for the latest 5-year period ending March 2018, indicates 3 non-injury crashes at this intersection in Harrow Road.

Given that most intersections within Rockdale Town Centre area are signposted with 'No Stopping' restrictions, the lack of signage at this intersection leads to an assumption amongst motorists that parking is allowed.

It is thus considered necessary to signpost the 'No Stopping' restrictions that apply at these intersections to reiterate the parking restrictions to the motorists. There is no loss of parking associated with the signposting of these restrictions, as under the NSW Road Rules 2014, these restrictions already apply at the location.



- 1. That the approval be given to the installation of parking restrictions along the western kerb line of Burch Lane south of Miles Street, as follows:
  - From 0 to a point 24m Retain 'No Stopping' restriction
  - From 24m to 44m Proposed change of existing [3P, 8am-6pm Mon- Fri, 8am-12pm Sat, Permit Holders Excepted – Area D] restriction to 'No Parking' restriction
  - From 44m to 58m Retain 'No Stopping' restriction
- 2. That the approval be given to the installation of parking restriction along the western kerb line of Burch Lane south of Hughes Avenue as follows:
  - From 0 to a point of 10m Retain 'No Stopping' restriction

## Background

Burch Lane, Mascot, is a narrow 4.5m wide lane, servicing a two-way flow. It does not allow access to off-street parking spaces in and affects safe passage of traffic with the current parking restrictions.

In order to enhance safety for the moving traffic and allow better access to off-street parking spaces, it is proposed that a 'No Parking' restriction be installed on the western side of Burch

Lane. The current parking restriction is (3P, 8am-6pm Mon- Fri, 8am-12pm Sat, Permit Holders Excepted – Area D). It is expected that 8-10 car spaces will be removed as part of this proposal.

Affected residents and businesses have been consulted. No objections have been received at the time of writing this report.





### Summary

Council has received a request to install additional 'No Stopping' signs around the turning bay in Carruthers Drive near The Scots College Brighton Preparatory.

Drivers have allegedly misinterpreted the areas delineated by the dish drain and kerb alignment as parking spaces. Currently, there are no signs which indicate that it is a turning bay. Further, there is only one existing sign that enforces the 'No Stopping' restriction around the turning bay which is insufficient.

## **Officer Recommendation**

That approval be given to the installation of three additional 'No Stopping' signs at the following locations at the cul de sac end of Carruthers Drive, Dolls Point:

- Adjacent to bollards along the northern kerb line No Stopping [L]
- Adjacent to bollards along the southern kerb line No Stopping [R]
- End of turning bay along the southern kerb line No Stopping [L]

## Background

Carruthers Drive runs in the east and then north directions. At the bend, Carruthers Drive has a road closure to vehicular traffic. The western approach of Carruthers Drive has been closed off to provide a public car park. The main entrance to the car park is via Russell Avenue

Carruthers Drive, east of Russell Avenue, also services The Scots College Brighton Preparatory and a carpark to the Depena Reserve, a popular recreational area. There is a kiss and ride zone along the northern kerb line of Carruthers Drive west of the turning bay which is used by parents to drop off and pick up their kids from school.

The turning bay allows drivers, particularly parents during school peak periods, to smoothly conduct a U-turn manoeuvre to exit into Russell Avenue and Malua Street.

Given the narrowness of Carruthers Drive and tight arrangement of the carpark, the turning bay is an essential facilitator of traffic, which must remain clear at all times to improve traffic safety and flow.





#### Summary

Council has received a request to change the existing 'No Parking 5.30 pm – 8.30 pm Wednesday, Council Vehicles Excepted' restriction along the southern kerb line of Edward Street, Botany opposite Botany Town Hall as it has become redundant since the amalgamation of the former Botany and Rockdale Councils.

In place of this redundant restriction, it is proposed the '2P, 6 am - 6 pm' restriction be installed.

## **Officer Recommendation**

That approval be given to the replacement of the existing 'No Parking 5.30 pm - 8.30 pm Wednesdays, Council Vehicles Excepted' restriction with a '2P, 6 am - 6 pm' restriction along the southern kerb line of Edward Street, east of Botany Road, opposite Botany Town Hall, as follows:

- from 0m to a point 11m retain existing 'No Stopping' restriction
- from 11m to 39m proposed '2P, 6am-6pm' restriction
- from 39m eastward retain existing parking restrictions

## Background

Edward Street is a wide local road that services mostly single and double storey dwellings and a few small residential apartment blocks. The eastern end of Edward Street meets Botany Road just south of a strip mall that accommodates numerous businesses and amenities.

An off peak site inspection revealed that parking on the eastern end of Edward Street is very limited, with at least 80% of parking spaces being occupied, presumably to access the strip mall.

The 'No Parking, reserved for Council vehicle' restriction was initially applied to provide parking spaces for councillors and other stakeholders attending the monthly Botany Bay City Council meeting. Council meetings have not occurred in Botany Town Hall since the amalgamation, and therefore the 'No Parking 5.30 pm – 8.30 pm Council Vehicles Excepted' restriction is no longer required.

The reserved parking spaces along the northern kerb line of Edward Street in front of Botany Town Hall was previously considered by Bayside Traffic Committee on 6/2/19, item BTC19.005. The Committee recommended:

That approval be given to the proposed change of a parking restriction along the northern kerb line of Edward Street between Botany Road and James Bourke Place, in front of Botany Town Hall from 'No Parking, 5.30 pm - 8.30 pm, Wednesday, Council Vehicles Excepted' to 'P5 Minutes, 1 pm – 6 pm, Tuesday, Permit Holders Excepted, AREA OTHER' restriction.

The southern kerb side parking of Edward Street opposite the Botany Town Hall is still remaining and is obsolete. Thus, it is recommended to replace the existing reserved vehicles parking restriction 'No Parking' restriction on the southern side of Edward Street, with a '2P, 6 am - 6 pm' restriction.



## Summary

Eve Street Cycleway north of Brennans Road, Arncliffe, is being heavily utilised by workers' vehicles from the nearby WestConnex / New M5 Project thereby forcing cyclists to ride on the road instead of on the cycle path. This is creating a potentially dangerous situation for cyclists.

## Officer Recommendation

That approval be given to the installation of 'No Stopping' restrictions along the eastern kerb line of Eve Street, Arncliffe, north of Brennans Road with:

- 'No Stopping' signage to be hung on the existing fencing
- 'No Stopping' yellow lines to be painted on the eastern edge of the road carriageway.

## Background

Over 20 years ago Council constructed a cycleway extending from the Princes Highway Wolli Creek to Cook Park Kyeemagh which forms part of the regional Cooks River Cycleway. A section of the route includes a section along the eastern side of Eve Street, Arncliffe.

Council's Rangers have reported that vehicles from the workers of the nearby WestConnex/ New M5 Project are now parking on the cycle path forcing cyclists onto the road creating a potentially dangerous situation. As there is no signage or linemarking along the cycle path the Rangers are not able to issue infringement notices for illegal parking.

The damaged PVC bollards will be maintained as part of the routine maintenance.

To prevent this illegal parking it is proposed to install "No Stopping" signs and paint continuous yellow 'No Stopping' line along the edge of the path along the eastern side of Eve Street.

#### Summary

Council has received a request for the provision of 'No Stopping' zones on Gladstone Street at the intersection with Dunmore Street Bexley as cars have allegedly been parking too close to the intersection and encroaching onto the carriageway, creating difficulties for drivers negotiating the intersection and pedestrians to walk through.

The 'No Stopping' zone needs to be extended greater than the standard 10m to sufficiently avoid the concrete median islands and pram ramps located at the intersection, and maintain a three (3) metre gap between parked cars and the centre line of the road.

#### **Officer Recommendation**

That approval be given to the provision of 'No Stopping' zones at the intersection of Gladstone Street and Dunmore Street North, Bexley, as follows:

- on the western approach of Gladestone Street, a 20m on the northern kerb line and 12m on southern kerb line.
- on the eastern approach of Gladstone Street, a 13m on the northern kerbline and 20m on the southern kerb line

### Background

Gladstone Street services a mix of single and double storey houses, and low-levelled apartment blocks. Onsite parking is limited at the apartment blocks and therefore, kerbside parking is in high demand in the area.

It is claimed that cars on Gladstone Street are parked too close to the intersection with Dunmore Street, creating a bottleneck in the carriageway. The matter is made worse by the presence of median concrete islands in Gladstone Street which further narrow the road carriageway width.

It is recommended that 'No Stopping' zones be provided on both approaches of Gladstone Street to Dunmore Street North as per the attached drawing, to maintain a safe access for moving traffic and pedestrians.





Council has received a request from St George Police Area Command, to review strategies to deter loitering and hoon behaviour in Kyeemagh Boat Ramp Reserve Carpark, off Mutch Avenue, in response to multiple complaints from local residents.

As a result, it is proposed to change the existing 'No Stopping 11pm-5am Vehicles with Boat Trailers Excepted' restriction throughout the carpark to 'No Stopping 9pm-5am Vehicles with Boat Trailers Excepted.

#### Background

Kyeemagh Boat Ramp Reserve Carpark is a popular access point for boats to the Cook River. The main vehicular access is via Mutch Avenue.

The water front and secluded location of the carpark make it a popular meeting/loitering destination, particularly at night. Local residents have claimed that hoon behaviour occurs frequently in the area, which council have attempted to deter by implementing several strategies such as installing CCTV, trimming trees back and applying a 'No Stopping 11pm-5am Vehicles with Boat Trailers Excepted' restriction throughout the carpark.

The 'No Stopping, 11pm-5am, Vehicles with Boat Trailers Excepted' restriction in Mutch Avenue boat ramp car park was recommended by Rockdale Traffic Committee on 14/2/2007, item RT16 and was adopted by Rockdale City Council on 21/2/2007.



#### Summary

On the 5 December 2018, the Bayside Traffic Committee endorsed the provision of a pedestrian crossing on Magdalene Terrance east of Mount Olympus Blvd. With the current kerb side parking arrangement, installing a pedestrian crossing will create an unsafe sight distance issue on the southern end of the crossing particularly when the parking spaces closest to the crossing on the southern kerb line are occupied by large trucks.

To rectify this issue, it is proposed to establish a 15m 'No Stopping' zone as per the attached drawing, which will result in the loss of two (2) parking space with '2P' restriction.

#### **Officer Recommendation**

That approval be given to the provision of a 15m 'No Stopping' zone, which will remove two (2) parking space, to improve sight distance at the new pedestrian crossing to be constructed.

#### Background

Magdalene Terrace is an arterial, two way road within the Wolli Creek Railway Station Precinct, which services a mix of residential and commercial properties. With the recent opening of the Aldi store at 4 Magdalene Terrace, pedestrian traffic is increasing. Bayside Council have proposed a network of pedestrian crossings throughout the area to address the forecasted increase in pedestrian traffic, which were endorsed by the Bayside Traffic Committee and Council in December 2018.

One of the proposed pedestrian crossings is located on Magdalene Terrace, just west of Mount Olympus Blvd. It is situated directly in front of the entrance to Aldi and is therefore a critical crossing area for pedestrians. However, with the current arrangement of parking along the southern kerb line of Magdalene Terrace, there is insufficient sight distance on the southern end of the proposed crossing when parking spaces are occupied.

The 12m 'No Stopping' zone proposed will meet the RMS's Technical Directions TDT2011.01 requirements for the marked foot crossings in terms of 'No Stopping' zones, with the kerb extension of 2m wide.



Council has received a request for the provision of 'No Stopping' signage at the intersection of Percival Street and Milsop Street, Bexley to reinforce the 10m statutory 'No Stopping' restrictions.

It was claimed that some parents of the nearby school have parked their vehicles too close to the corners of the intersection and blocked the safe passage of moving traffic.

#### Officer Recommendation

That approval be given to the installation of 'No Stopping' signs to reinforce the statutory 10m of 'No Stopping' zones at the intersection of Percival Street and Milsop Street as follows:

- a) Western kerb line of Percival Street south of Milsop Street proposed 14m 'No Stopping' signage due to the presence of a speed hump in Percival Street
- b) Eastern kerb line of Percival Street south of Milsop Street proposed 15m 'No Stopping' signage due to the presence of a speed hump in Percival Street







### Summary

Council has received complaints about cars parking in front of a new pram ramp installed at 2 Reading Road, Brighton Le Sands.

An aged care home is located at 2 Reading Road, and many patients, particularly those bound to a wheelchair, rely on the pram ramp to travel to and from vehicles parked along the kerb.

#### **Officer Recommendation**

That approval be given to the installation of 'No Stopping' restriction at a new pram ramp located at 2 Reading Road, Brighton Le Sands.

### Background

Reading Road is a local residential street that offers kerbside parking on either side of the road with no time restrictions. An aged care home is located at 2 Reading Road, and patients, particularly those in wheelchairs, rely on the pram ramp outside of the property to access vehicles parked along the kerb. The pram ramp was required under the condition of consent linking Reading Road to a pedestrian gate of the Aged Care centre.

As the pram ramp is new, cars are frequently found parked in front of the pram ramp, obstructing the most convenient access for elderly patients and other pedestrians.

It is recommended that a 'No Stopping' restriction be provided at the new pram ramp at 2 Reading Road to deter drivers from parking.



#### Summary

Council had received a request to review safety of exiting traffic at the driveway to 60 Robey Street, Mascot. This site provides service departments for short stays similar to Hotels. It accommodates approximately 144 parking spaces. The number of vehicles exiting from the driveway is high.

#### Officer Recommendation

That the existing 'No Stopping' restriction be extended to cover 6.5m east of the exit driveway of 60 Robey Street, Mascot, to provide a better view of oncoming traffic.

### Background

A new building has been constructed at 60 Robey Street, Mascot and completed by the end of 2017, in accordance with DA 14/207/2. Parking issue at this site was previously considered by Bayside Traffic Committee on 4/7/2018, item BTC18.106. The Committee recommendations were:

- 1 That approval be given to the installation of three 'No Stopping' zones across three newly constructed driveways to 60 Robey Street, Mascot, as follows:
- a) the western driveway, nearest to the common boundary of Nos. 60 and 62 Robey Street – proposed 8.7m 'No Stopping' zone
- b) the middle driveway proposed 8.7m ' No Stopping' zone
- c) the eastern driveway proposed 14.7m 'No Stopping' zone
- 2 That existing '3P, 8 am 6 pm, Mon Fri, 8 am 12 pm, Sat' Permit Holders Excepted Area A' signage be reinstated, in front of 60 Robey Street Mascot.

The above recommendations had been since implemented by the developers with the 'No Stopping' zones were installed at 1m away from the driveways.

However, a recent request has been received to provide better sight distance for exiting traffic from the car park to Robey Street.

Upon site inspection, it was found that sight distance can be improved by extending the existing 'No Stopping' restriction to cover 6.5m east of the exit driveway of 60 Robey Street, Mascot. One parking space for the 3P parking limit, will be curtailed as a result of the proposal.

No crashes at the driveways to this site, had been reported since the implementation of the 'No Stopping' zones.

The applicant will bear the associated costs as this is a recent development.

2 That parking situation in Stephen Road be revisited in a 12 month time after the installation of the new proposal.

### Background

Stephen Road is a regional road situated in a mixed residential/industrial zones of Botany.

Parking demand is high.

Currently, there are more than 80m of a combined 'No Stopping' and 'No Parking' restrictions along the southern approach of Stephen Road to the signalised intersection of Swinbourne Street and Stephen Road. Among these restrictions, there is a 24m 'No Parking' restriction south of the driveway to No. 30-32 Stephen Road.

Historical information on the reason for the 'No Parking' zone and the reason for having a very long 'No Stopping' and 'No Parking' zones in Stephen Road is not available.

It is recommended that the 'No Parking' restriction be shortened to 12m to provide 2 more parking spaces for residents whilst maintaining sufficient sight distance of oncoming traffic on both directions.

#### Items without notice

Items which do not appear on the agenda (that is items without notice), must only be considered if the elected Council has referred the matter to the Committee, and Council officers have been able to prepare a report on the proposal in the normal manner. Items raised without notice must be referred to the next Committee meeting (or dealt with separately between meetings) if any member of the committee requests time to consider the issue.

All other Items without notice are referred to Council officers in the first instance, unless the members of the Committee agree to consider the item.

Matters that have been investigated and warrant the exercise of the Delegation to Council for the Regulation of Traffic, will be referred to the Bayside Traffic Committee at the next available opportunity.

Other matters that have been investigated and do not require exercise of the Delegation to Council are dealt with as administrative matters and the appropriate response and action will be provided (such as providing advice to customers, referral of matters to the relevant authority, replacement of missing signs, repainting line marking). These matters will not be referred to the Bayside Traffic Committee.

#### Informal Items - Traffic Engineering Advice

In accordance with the Roads and Maritime Service Guidelines, the Bayside Traffic Committee (BTC) members may wish to consider traffic issues or seek advice, on matters that are outside the Delegation to Council for the Regulation of Traffic from the Roads and Maritime Service (such as installation of speed limits or traffic control signals). As these issues do not require the exercise of delegated functions at that point in time (though they may or may not require it in the future) they should not be dealt with as formal items by the BTC. The BTC members may take advantage of the knowledge and experience of the other members to help them to resolve or clarify an issue. When wishing to utilise the expertise of

the BTC members in this manner, Council will include items on the agenda under a separate Informal Items section. Informal items should be dealt with after the formal BTC items where Council intends to exercise a delegated function have been considered. Any outcomes from discussions on informal items cannot be included in the BTC report to the Council. However, Council can use any outcomes from these discussions in their deliberations on such issues.
