BTC19.119 Arncliffe Street and Burrows Street road bend in Wolli Creek - Proposed 'No stopping' restriction

Committee Recommendation

That approval be given for the installation of two (2) 'No stopping' signs to restrict the problematic parking next to the road bend that links Arncliffe Street with Burrows Street in Wolli Creek.

BTC19.120 Fraser Avenue and Boonah Avenue, Eastgardens - Parking issues

Committee Recommendation

Summary

Council has received a request from a resident of Caroma Avenue, Kyeemagh to improve safety around the bend due to parked vehicles.

Officer Recommendation

CRM 232047

That approval be given to the installation of 'No Parking' restrictions across the driveway of number 3 Caroma Avenue and 3m on either side of it.

Background

Caroma Avenue, Kyeemagh is a local street off Bestic Street. It is primarily residential and carries very low traffic volumes. The street is 7m in width and is considered narrow for two-way street with parking permissible on both sides.

Based on the RMS crash data, there has been no reported crashes in the street in the latest 5-year period ending September 2019.

However, the resident has indicated that gradually over the years with increase in car ownership in the street, more and more vehicles are parked on-street including boats and trailers. When the vehicles are parked too close to the bend, it restricts the visibility of oncoming vehicles whilst exiting from driveways causing a potential for conflict.

It is therefore recommended to install 'No Parking' restrictions outside house number 3 as per the attachtment.



Summary

Council has received a request to review existing 'No Parking' restrictions in Catherine Street west of Princess Highway, Rockdale to facilitate access to building carparks.

Officer Recommendation

That the existing 'No Parking, 8:30am – 6pm Mon- Fri, 8:30am – 12:30pm Sat' restriction at the northern kerbline of Catherine Street west of Princess Highway, Rockdale, be changed to 'No Parking'.

Background

Catherine Street, Rockdale, is a one-way residential street west of Princess Highway. The road carriageway width is approximately 5.2m and parking is allowed on the northern side of the street over evening and night.

A request has been received from a resident living in No. 613-615 Princes Highway, to extend 'No Parking' restrictions to be full time as currently parking is allowed outside business hours where parked vehicles impede access to building driveways.

It is thus recommended that the existing 'No Parking, 8:30am – 6pm Mon- Fri, 8:30am – 12:30pm' restriction be changed to a 'No Parking' restriction improve access and resolve the ongoing issue of parked vehicles across driveways.

The locality of the proposed restriction is shown in the attached drawing.

Summary

A request has been received to review parking restrictions at Church Avenue, Mascot.

Officer Recommendation

That approval be given to the installation of a 'No Stopping' restriction at the southern kerbline of Church Avenue between O'Riordan Street and Bourke Street, Mascot, in front of Sydney Water Land "Linear Park" to provide better traffic flow and safer pedestrian crossing.

Background

Church Avenue is a local street in Mascot. Parking is limited in the area which accommodates a mix of residential, commercial and retail properties as well as public transport amenities.

A culvert is present in Church Avenue where the width of the road is 5.8m in front of "Linear Park". This is further reduced by parked vehicles.

There is a desire line for pedestrians to cross Church Avenue to access both sides of "Linear Park". Parked cars at this location impair visibility and do not allow a safe crossing place for pedestrians especially with prams causing safety concerns.

It is recommended to install a 'No Stopping' restriction to provide smoother traffic flow and safer crossing point for pedestrians accessing "Linear Park". This is consistent with the treatment on the northside kerb line.



footpath closure for 12 months

Summary

A request was received for the endorsement of a Construction Traffic Management Plan and changes to existing traffic facilities as part of the construction of a mixed use development at 19A Evans Avenue, Eastlakes.

Officer Recommendation

That the consultants be given an opportunity to present the Construction Traffic Management Plan, for 19A Evans Avenue, Eastlakes, to the Bayside Traffic Committee for comments.

Background

Evans Avenue is a two-way local street in Eastlakes that provides access to Eastlakes Shopping centre and Eastlakes reserve.

Traffic consultants for the development (DA-17/1134) at 19A Evans Avenue, Eastlakes have prepared a Construction Traffic Management Plan (CTMP) to detail traffic management procedures and systems for the demolition, excavation, building and civil construction stages for the proposed mixed use development. The development has frontages along Gardener's Road and Evans Avenue.

The applicant is proposing to close the northern footpath in Evans Avenue between Racecourse Drive and Barber Avenue for a period of 12 months to utilise footpath for parking construction vehicles as kerbside parking is not feasible along Evans Avenue frontage. The width of Evans Avenue along the site frontage is 8m.

Part of the proposal is to construct two temporary pedestrian crossings in lieu of the existing pedestrian crossing to maintain pedestrian access at both ends of the proposed footpath closure. The existing pedestrian crossing will be reinstated and the two temporary pedestrian crossings will be removed when construction work is complete. It has been identified that a number of pram ramps will have to be constructed in order to facilitate this change.

The consultants would like to address the Bayside Traffic Committee in regards to the traffic impacts of their construction traffic management plan.



Subject Gladstone Street, Bexley, between Harrow Road and Queen Victoria

Street - Proposed Traffic Calming Scheme

Summary

Council has received requests for the provision of a traffic calming scheme in Gladstone Street, Bexley, due to speeding vehicles.

Officer Recommendation

That approval be given to the installation of two rubber cushion pads, in front of nos. 32/34 and 10/12 Gladstone Street between Harrow Road and Queen Victoria Street, Bexley, subject to the availability of funding.

Background

Gladstone Street is a 9.5m wide residential street in Bexley, linking Harrow Road, a State Road, to the north with Queen Victoria Street, a regional road, to the south.

It has been reported that vehicles speed through Gladstone Street between Harrow Road and Queen Victoria Street exceeding the prevailing conditions of the road.

Currently, there are some traffic control devices in Gladstone Street:

- At the northern end, a left turn slip lane out into Harrow Road for the northbound traffic.
- At the mid-block, road narrowing scheme at the intersection of Gladstone Street and Dunmore Street North.
- At the southern end, a pedestrian refuge island immediately north of Queen Victoria Street.

Consultation was carried out with the affected residents in Gladstone Street regarding the proposed traffic calming scheme including rubber cushion pads. Subsequently, fifteen (15) responses were received with 12 responses in support of the proposal.

Traffic Count Data

The latest traffic count indicates the 85th percentile speed was recorded to be approximately 56km/h and a five day average daily volume of 1,232 vehicles per 24 hours. The recorded speed is not acceptable for the 50km/h residential street.

Effects of speed humps

Studies of the effects of speed humps have shown that the traffic volumes of through or non-local traffic can be reduced by 33%. The estimated cost to provide speed humps (rubber cushion pads) in Gladstone Street is approximately \$10,000.

Accident data

Upon review of the accident data in the past 5 years ending September 2018, one injury crash had been reported in Gladstone Street.

Load limit restriction

There is a load limit restrictions in Gladstone Street, Bexley.

Bus Services

Buses services do not operate in Gladstone Street.

The locality of the proposed traffic calming scheme in Gladstone Street is shown in the attached document





Officer Recommendation That the existing 10m 'No Stopping' restriction in Hannam Street west of John Street, Bardwell Valley, be extended by 2.5m as the current 3.8m parking space is not compliant. **Background** Hannam Street is situated in a residential area in Bardwell Valley. A request has been received from No. 46 Hannam Street, where the resident requested to extend the 'No Stopping' zone as vehicles are continuously encroaching on the driveway of No. 46 Hannam Street when parked in the 3.8m space, making access to his property a daily struggle. Officer Recommendation That no changes are proposed to traffic conditions in Hughes Avenue, Mascot. Background Council has received a request about speeding concerns in Hughes Avenue. Hughes Avenue is a residential street between Botany Road and O'Riordan Street. It is part of a resident parking scheme in the area with 3 hour parking limit. Annual average daily traffic volume in the street is 450 vehicles per and 85th percentile speed is 49kmh. Based on the crash data provided by the RMS for the latest 5 year period ending June 2018, there have been no reported crashes in the street. Traffic calming and speed management devices are normally installed on an area wide basis for them to be effective and are prioritised based on crash history and other traffic data analysis. Road safety depends not just on engineering measures but enforcement and education as well as driver attitudes and behaviour. Summary

To provide parking access to Scarborough Park for people with mobility difficulty, Council will be adjusting the signs and line marking for the on-street carpark in Production Lane, Kogarah.

Officer Recommendation

That approval be given for the relocation and realignment of parking bays and disabled parking signs to create 2 compliant accessible parking spaces.

Background

The existing on-street car spaces in Production Lane, Kogarah are highly used by nearby businesses as well as patrons of sporting clubs operating within the park. People with disability have difficulty in finding parking near the new amenities block as most of the car spaces are occupied during all business hours.

To address this issue and to support Council's recent upgrade to the sporting amenities block in Production Lane, it is proposed to adjust the line marking for 8 car spaces in Production Lane to create 2 accessible car spaces and a shared area to comply with the requirements of Australian Standard 2890. The shared area will be located the newly built pram ramp, which shall give people with disability an easy access to Scarborough Park. All new line marked car spaces will have a dimensions of 2.4m x 4.8m.



Council received a request to review parking restrictions in Thompson Street, Arncliffe, as drivers are regularly parking within close proximity of the intersection making it an ongoing compliance issue.

Officer Recommendation

That approval be given for signposting the statutory 10m 'No Stopping' restriction along the western kerb line of Thompson Street, east of Booth Street, Arncliffe.

Background

Thompson Street is a 10m wide street that is situated in a residential area east of Booth Street, which is a split level 6m wide street, in Arncliffe. It has been observed that motorists have been regularly parking in the statutory 'No Stopping' zone contrary to NSW Road Rules resulting in a compliance issue.

Background

Items without notice

Items which do not appear on the agenda (that is items without notice), must only be considered if the elected Council has referred the matter to the Committee, and Council officers have been able to prepare a report on the proposal in the normal manner. Items raised without notice must be referred to the next Committee meeting (or dealt with separately between meetings) if any member of the committee requests time to consider the issue.

All other Items without notice are referred to Council officers in the first instance, unless the members of the Committee agree to consider the item.

Matters that have been investigated and warrant the exercise of the Delegation to Council for the Regulation of Traffic, will be referred to the Bayside Traffic Committee at the next available opportunity.

Other matters that have been investigated and do not require exercise of the Delegation to Council are dealt with as administrative matters and the appropriate response and action will be provided (such as providing advice to customers, referral of matters to the relevant authority, replacement of missing signs, repainting line marking). These matters will not be referred to the Bayside Traffic Committee.

Informal Items - Traffic Engineering Advice

In accordance with the Roads and Maritime Service Guidelines, the Bayside Traffic Committee (BTC) members may wish to consider traffic issues or seek advice, on matters that are outside the Delegation to Council for the Regulation of Traffic from the Roads and Maritime Service (such as installation of speed limits or traffic control signals). As these issues do not require the exercise of delegated functions at that point in time (though they may or may not require it in the future) they should not be dealt with as formal items by the BTC. The BTC members may take advantage of the knowledge and experience of the other members to help them to resolve or clarify an issue. When wishing to utilise the expertise of

the BTC members in this manner, Council will include items on the agenda under a separate Informal Items section. Informal items should be dealt with after the formal BTC items where Council intends to exercise a delegated function have been considered. Any outcomes from discussions on informal items cannot be included in the BTC report to the Council. However, Council can use any outcomes from these discussions in their deliberations on such issues.
