SPORTSPERSON of the Year

GUIDELINES AND OFFICIAL NOMINATION FORM

About the Award

The Sportsperson of the Year award is presented annually by Bayside Council for outstanding sporting achievements in any sport and sub-groups within them (eg disabled and veteran categories).

All nominations are assessed in strict confidence by a selection panel which is a representative of the community. The winner will be announced at a presentation ceremony on 26 January as part of Council's Australia Day program.

Criteria and Eligibility

1. Nominations can be made by any individual or organisation.
2. Nominee must be an Australian Citizen, please provide proof of Citizenship (Birth Certificate, Passport or Certificate of Citizenship) and must be a Bayside Council resident.
3. The following people cannot be considered for Council's Citizen of the Year, Young Citizen of the Year and Sportsperson of the Year Awards:
 - Current employees of Bayside Council, and their spouses or defacto partners or relatives. Relatives includes those persons related by blood or marriage.
 - Present Councillors, Federal or State politicians and their spouses or defacto partners or relatives. Relatives includes those persons related by blood or marriage.
4. Nominee must be a resident of the Bayside LGA (Local Government Area) or represent a local sporting organisation.
5. Nominee must not have received this award previously.
6. One Award is presented each year and the recipient is to be known as the 'Bayside Sportsperson of the Year', however, in exceptional circumstances two awards will be granted.
7. The name of at least one referee (other than the nominator) must be supplied with the nomination.
8. The nomination must explain the achievements and background of the nominee and the reasons for the nomination.
9. The nominee must show team participation and leadership qualities if a team player.
10. The nominee must demonstrate strong ethical and community values.
11. Consideration will be given to a nominee's sporting achievements in the year immediately prior to the year the award is being considered for.
12. Council's decision is final and no correspondence will be entered into.
13. All nomination information and material submitted remains the property of Bayside Council.
14. Anything done or omitted to be done by the former Council and having any force or effect immediately before the amalgamation day continues to have affect.
