5.4 Planning, Development and Compliance Matters

Director City Futures, Michael McCabe and Manager Compliance, Michael Azzi provided an update as to the current status of 1441 Botany Road (Former Police Station) and property at 1445-1447 Botany Road.

The BHT were advised that:

- the former police station is State-owned and Bayside Council has no control over it.
- The DA 2018/329 for 144-1447 Botany Road for demolition was withdrawn, however the DA 2018/1201 for mixed use development is stil active and remains under assessment.

Background

The Community History Team aims to increase awareness within Bayside by responding to enquiries, producing exhibitions, digital content and delivering a variety of community programs.

Enquiries

- Location of Correy's Tea Gardens.
- Coward Street, Mascot and first Mayor of North Botany, James Coward.
- Alderman John Blacker of North Botany.
- Location of an aboriginal burial ground near the Sir Joseph Banks Hotel.

Exhibitions

• Visual Arts Prize and CamerART.

These two exhibitions were on display in the George Hanna Memorial Museum during April and May and were very popular. These exhibitions of art and photography attract new audiences to the museum.

• People & Planes: A Community View of Sydney Airport

The new exhibition, celebrating 100 years since the founding of Mascot Aerodrome, opened on 8 July and will be on display until the end of January 2020. It has already attracted great interest and 35 children were given a tour on the second day of opening. The Children's and

Youth Librarian planned school holiday activities with an airport theme. Children have made airports, planes, space shuttles and parachutes.

Public Programs

• The Wretched Flu

Approximately 40 people attended a talk by the Community History Librarian on Saturday, 4 May at the Mascot Library and George Hanna Memorial Museum. The talk was held in conjunction with the National Trust's Australian Heritage Festival. This year's theme was **Connecting People, Places and the Past.** The Community History Librarian spoke about the effect of the Pneumonic Influenza (Spanish Flu) pandemic of 1919 on the communities of Botany and Mascot. Attendees were particularly interested in the handwritten lists of local residents who were inoculated at the Botany Town Hall depot during January and February 1919.

• The Daredevil Dairyman

To help promote the new exhibition, a talk will be given by the Community History Librarian about the remarkable life of Rockdale aviator, Reginald Annabel. During a few short years he flew around Australia in his gypsy moth plane, flew under the Sydney Harbour Bridge and built a number of planes on his Rockdale dairy farm. He was tragically killed looping the loop at Mascot in 1934. His scrapbook, photo album and trophy have been loaned to the Community History Team and are on display in the new exhibition.

• Ron Rathbone Local History Prize

The 2019 Ron Rathbone Local History Prize for original research closes on 26 July. There is a \$5000 prize for the winning entry and \$500 prizes for the best primary and high school entries. BHT President, Anne Slattery and committee member, Dr Peter Orlovich are both members of the judging panel. The award ceremony will be held at Rockdale Library on Saturday 7 September.

Summary

Improvements to Arthur Park are listed on Councils Capital Works Program to be delivered this financial year.

The proposed park improvements will continue to recognise and highlight the heritage significance of the park whilst creating better alignment of pathways and fostering more utilisation and enjoyment through play spaces, sensory gardens and seating.

A Concept Plan of the proposed improvements has been developed, and it is planned to undertake community consultation in the early part of the 2019/20 financial year, with construction to be carried out in the second half of 2019/20.

Officer Recommendation

That the BHT Committee

- 1 Provides feedback on the proposed design for the park improvements.
- 2 Requests that Council notifies BHT members about the project as part of the community consultation process.

Background

Improvements to Arthur Park are listed on Councils Capital Works Program to be delivered this financial year.

In late January 2019 Council engaged the services of a landscape architecture consultancy to undertake design improvements to the park. The design has been guided by a preliminary masterplan that was prepared by the former Botany Bay City Council in 2013.

A tree survey of the park was undertaken at the time of the 2013 preliminary masterplan, with a particular focus on the existing memorial avenue of poplar trees that, in association with a number of individual plaques on a plinth, acknowledges local service men and women who served their country in both World Wars. At that time a number of the poplar trees (*Populus deltoides*) - were removed as they were in poor condition and the remaining trees retained.

Six years later, in March 2019, an arborist assessment of all trees was undertaken and confirmed the remaining 9 poplars are in poor condition and should also be removed.

It is proposed to replace the poplar memorial trees with birch trees along a new memorial avenue through the park to continue to recognise the ex-service men and women.

In planning discussions with the Botany RSL sub-branch, it was agreed the number of trees in any new memorial avenue should be consistent with the number of people acknowledged in the plaque – this being 26.

During discussions, the Botany RSL sub-branch advised the existing memorial plaque was in the process of being researched and replaced in collaboration with the Botany Historical Trust. A new interpretative sign is also being produced to support the memorial. It was agreed that the memorial plinth, the replacement plaque and the interpretative sign were to remain and be included in the new design.

A concept design has been developed and will be presented at the meeting. Improvements proposed in the design include:

- a Retention of the two existing pergolas and creation of a small sensory garden close to the former health centre building with seating.
- b Removal of the remaining poplar trees and the installation of a new living memorial avenue of 26 birch trees realigning the existing pathway.
- c New improved path connections throughout the park.
- d Re-location of the existing memorial stone plinth with the memorial plaque and new interpretative sign to be placed in close proximity to the new pathway.
- e Inclusion of a small children's play space with seating.

Community consultation will commence in the early part of the 2019/20 financial year, with construction to be carried out in the second half of 2019/20.

Consultation will include:

- Information board placed in the park.
- Notification to neighbouring residents.
- Botany RSL Sub-Branch and BHT Members.
- "Have Your Say" on-line survey.
- Information on Council's website.

The community will be able to provide feedback about the proposed improvement through the 'Have Your Say' portal on Council's website <u>https://haveyoursay.bayside.nsw.gov.au/</u>.

Background

1441 Botany Road (Former Botany Police Station) and 1445-1447 Botany Road, Botany

At the May Botany Historical Trust meeting, an update was provided by the Director City Futures - Michael McCabe and the Manager Compliance - Michael Azzi as to the current status of 1441 Botany Road (former Botany Police Station) and the property at 1445-1447 Botany Road.

The Botany Historical Trust was advised that:

- the former police station is State-owned and Bayside Council has no control over it.
- the DA 2018/329 for 1441 1447 Botany Road, for demolition, was withdrawn however, the DA 2018/1201 for mixed-use development is still active and remains under assessment.
