- There is no age restriction on who can enter, Council is encouraging entries from all age groups in our community. The completion is open to residents of Bayside Local Government area only.

- Entries close on 31 October 2021.

Winner Selection

- All submissions will be reviewed and shortlisted to proceed to stage two.
- There may be one or multiple winners – the Mayor may choose to have a selection of cards.
- Winners will be notified by email.
- Winners names will be published in Councils promotional material including print, digital and social media.
- The winner/s will each receive a set of the cards once printed, along with a certificate of recognition.

General Terms & Conditions

1. Entry into the competition is deemed acceptance of these terms and conditions. Information relating to the competition and the above schedule form part of the terms and conditions for the Bayside Christmas Card Competition. Bayside Council as the promoter may vary these terms and conditions at its sole discretion, in accordance with Australian law.
2. Eligibility to enter the competition is subject to restrictions noted above.
3. Entrants must complete the entry form and follow the process as outlined in the entry details, entries must be received during the submission period as noted above
4. Entrants may submit a maximum of one design per person or one design per collective group of persons.
5. All entries must be submitted individually and must meet eligibility requirements. That is must live in the Bayside LGA or be from a school within the LGA.
6. Entries that are incomplete or contain inappropriate content will be deemed invalid and disqualified. No responsibility is accepted for the late, lost, delayed or misdirected entries.
7. Bayside Council reserves the right to request proof of identity and proof of residency within the Bayside Local Government area. If proof cannot be provided the entry will be deemed invalid.
8. Bayside Council's decision is final and no correspondence will be entered into.
9. All entrants must abide by relevant laws, including copyright and antidiscrimination. All entries must be of original creation/ design by the named entrant or entrants and free from any claims that they infringe third party rights.
10. Bayside Council is not responsible for any costs, losses or damages associated with the entry of a submission or circumstances arising from a submission.
