On completion of this form and payment of the fee, Council will provide:

- Flood Advice/Certificate confirming if the subject property is affected by flooding and/or overland flows in the 1% Annual Exceedance Probability (AEP) (1 in 100 chance in any year) flood and the Probable Maximum Flood (PMF).
- Advise of the 1% AEP and PMF levels within the site, which will inform flood related development controls defined in Council's Development Control Plan.
- Provide flood maps of the site showing flow depth, direction and flood function.
- Or provide access to the Flood model.
- Council will provide advice in 10 business days.
