

Off Site Tree Replacement Election	DA-20 /

BACKGROUND

- A. In accordance with Bayside Council **Development Control Plan 2022** 3.8.2 accepts offset planting on public land subject to an applicant or property owner entering into a deed of agreement that is supported by a condition of consent under s4.16 of the Environmental Planning and Assessment Act.
- B. The purpose of this Agreement is to provide for a funding arrangement between an applicant and Council where Council has approved an application involving the removal of tree/s required by way of a condition of consent replacement planting. An applicant may choose to either replant on private land at the ratio required or enter into an arrangement with Council to provide funding to Council for the replanting of the trees on public land.

C. The parties to this Agreement:

- Acknowledge that maintenance of the tree canopy in Bayside has been identified as a key environmental factor and increase in improving the quality of urban life
- Recognise that the Bayside tree canopy is under pressure from increased residential densities. Lot sizes
 have reduced over time and houses have become larger. In combination with changes in lifestyle that have
 resulted in more paving and in-ground pools there is reduced space available for the planting of trees on
 private land
- Accept this Agreement as satisfying a condition of consent on the Development Application nominated above provided that all trees that are subject to a replanting requirement in the Consent have been accounted for either through this Agreement or replaced on site at the appropriate ratio.

D. The Consent specifies that a Tree Location Plan must be lodged with Council prior to the issue of a Construction Certificate, nominating the location and species of trees to be replanted. Where an applicant is relying on this Agreement to satisfy the Consent, this Agreement must be in place prior to the issue of a Construction Certificate.
