- Council will review the application on merit, and review if there is a demonstrated need for line marking, such as numerous confirmed complaints of blocked driveway, limited sight distance or obscure driveway. Council reserves the right to approve or reject the application.
- Driveway line marking fee is payable by the applicant subject to approval.
- The lines will be 2.5m long, 100mm band and painted by Council's Contractors at lip of the gutter on existing driveway wing on either side of the driveway. Please see diagram attached.
- Council is not responsible for the maintenance or repainting the lines. If the applicant wishes the maintenance to be carried out, it will be additional cost to the applicant.

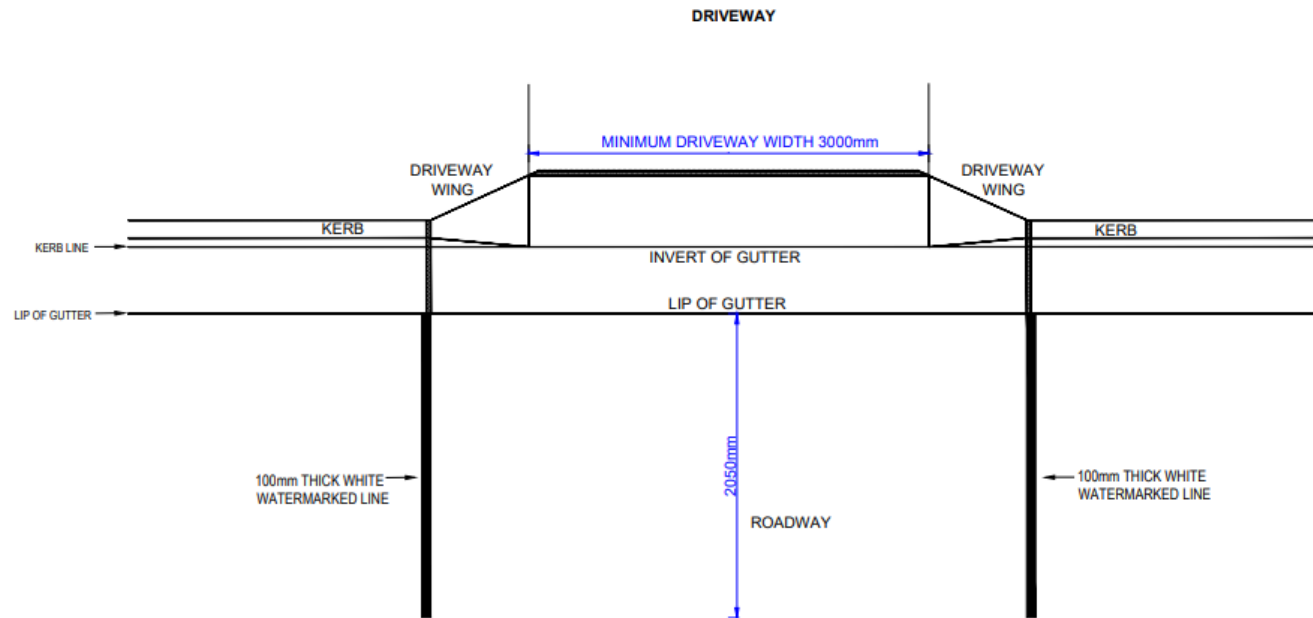

  - 100mm THICK WHITE WATERMARKED
  - AT THE EXISTING WING END POINT AT EITHER END OF DRIVEWAY
  - MAX. SPACE WIDTH 2500mm FROM THE INVERT OF THE KERB (2050mm FROM THE LIP OF GUTTER). MIN SPACE WIDTH TO BE 2100mm ON NARROW STREETS
  - VARIATION TO POSITION OF LINE MARKING IS SUBJECT TO COUNCIL'S APPROVAL
2. APPLICATION AND LINEMARKING COSTS TO BE CHARGED FROM THE APPLICANT IN ACCORDANCE WITH COUNCIL'S FEES AND CHARGES.
